List of Member State measures partially funded by the Recovery and Resilience Facility (RRF)

The Recovery and Resilience Facility (RRF) is a temporary instrument that is the centerpiece of NextGenerationEU, the EU's plan to emerge stronger and more resilient from the current crisis. Through the Facility, the Commission raises funds by borrowing on the capital markets (issuing bonds on behalf of the EU). These are then available to its Member States, to implement ambitious reforms and investments that make their economies more sustainable, resilient, and prepared for the green and digital transitions, in line with the EU's priorities.

Many RRF measures proposed by Member States, such as certain infrastructure investments and direct support to citizens, are not subject to State aid control. For such measures, prior notification to the Commission is not necessary. Other measures are likely to constitute aid but will be exempted from the prior notification obligation as they will fall within the scope of block-exemption rules, in particular the General Block Exemption Regulation ("GBER") or be covered by an existing approved scheme. These measures can therefore be immediately implemented by Member States, without notification.

Below list concerns State aid measures included in an RRP that needed to be notified to the Commission for approval prior to their implementation, and which are dealt with by DG Competition with priority. This list includes only those cases where the Member State has indicated that RRF funding will be used.
