









This table shows a breakdown of the decisions according to the procedure followed to conclude the cartel investigation (corresponding to the number of decisions included in Tables 7 and 8). In general, the procedures used are: normal, settlement and hybrid. Hybrid procedures refer to decisions adopted under the normal procedure against parties that opted out of a settlement procedure when a settlement decision is adopted (at the same or at a later date) against the other parties. Re-adoptions are decisions that have been adopted after a (partial) annulment by the court. The table does not include the decisions on procedural aspects.




